National Judicial Opioid Task Force


Led by co-chairs Indiana Chief Justice Loretta H. Rush and, our very own, Tennessee State Court Administrator Deborah Taylor Tate, the NJOTF distributed a nationwide survey in 2017 which revealed six major needs: 1. state opioid plans: 2. the impact of the epidemic on courts; 3. court interventions for adults, juveniles and families; 4. treatment interventions; 5. specialty court/docket interventions; and, 6. funding.

The Mentor Boot Camp provides foundational professional development to strengthen veteran mentor programs in veterans treatment courts across the nation.

The Justice For Vets Mentor Boot Camp is a free, two-day curriculum designed to provide veteran mentors working with veterans treatment court participants the knowledge and skills to support them throughout the program. It consists of nine training sessions that emphasize professional skill development. Our experienced faculty and staff will guide veteran mentors as they fulfill their mission of engaging, encouraging and empowering their mentees.

Mentors that complete the two-day curriculum will receive a certificate of completion and will be able to register with our online National Mentor Corps to receive ongoing, web-based professional development.

Tennessee Judge Receives Highest Judicial Honor for His Work on the Opioid Epidemic



Judge Duane Slone is the 2019 recipient of the National Center for State Courts' William H. Rehnquist Award for Judicial Excellence- one of the highest judicial honors in the country. Judge Slone is being recognized for his work helping people with opioid use disorder. This award will be presented to Judge Slone by the Chief Justice of the United States John G. Roberts, Jr. during a ceremony at the U.S. Supreme Court on November 21.

The Rehnquist Award honors a state court judge who demonstrates the qualities of judicial excellence, including integrity, fairness, open-mindedness, knowledge of the law, professional ethics, creativity, sound judgment, intellectual courage, and decisiveness.

Judge Slone possesses each of these qualities, and more, said Tennessee State Court Administrato, Deborah Taylor Tate. "Judge Slone has demonstrated outstanding judicial leadership, personal and professional integrity, and pure heart in using his platform as a judge to combat the opioid crisis ... He has been an innovator, an initiator, a collaborator, and a visionary ... and most importantly, his numerous systemic changes have saved lives."

The Latest in Sumner County

"Sumner County Recovery Court has been pretty busy during the month of September!! With the help of Tennessee Lifeline's, Will Taylor, and Sumner County Anti-Drug Coalition we had our FIRST ANNUAL RECOVERY FEST!!! We had an amazing turnout and feel it was a huge success. We had over 300 in attendance with approximately 40 exhibitors. We can't wait to do it again next year!

In order to recognize Overdose Awareness Day, Recovery Court, with the help of the Sumner County Anti-Drug Coalition and Volunteer Behavioral Health, Recovery Court participants and staff wore purple "End Overdose" t-shirts and blew up helium filled purple balloons that we hung all around our downtown square. We were grateful to receive purple wreaths made by a staff person at Volunteer Behavioral Health that adorned the doors of the courthouse and our treatment office. It was a day to honor those we have lost to addiction and bring awareness to the disease.

We also networked with the Anti-Drug Coalition to recognize suicide awareness. Our staff and participants along with other agencies in Sumner County dressed in "Tennessee Speak UP...Save Lives" t-shirts, took selfies and posted to social media with #speakup19.

Recovery Court was recognized by the County Commission on September 16, 2019 and the City of Gallatin on September 17, 2019 with a proclamation, from each Mayor, declaring September as Recovery Court Month.

We were very fortunate to open up our first Recovery Court Transitional Living house this month, with all beds filled at this time."
