Dear members, partners and all,

2021 is over and was the year of the application of the MDR (EU) 2017/745. All PRRCs have started their job function, and we started to have some feedback from this new position.

In 2022, we have decided to bring more to our members. We plan many webinars (once per month) and a physical event including presentations from key speakers and round tables to know more about you, doing networking, between October and November 2022, if pandemic situation allows us to realize it and if we have enough people attending this event.

Then, to make viable the Contributors team (the members of the association who want to participate actively to the future projects of the association), we plan to do some round tables only for them and discuss topics where the PRRC is involved.

We remain committed to drive things forward sharing values of equity, integrity, mutual aid and humanity. I also take this opportunity to thank all our members and sponsors who supported us reaching our target in 2021 and are still supporting us towards achieving the strategical target of our association.

Editorial

Dear members, bonjour!

This year will mark the application of the IVDR, in 26th of May, 2022. Thanks to the application of the MDR, we got some feedback about the role of the PRRC, and Manufacturers of IVD sector are better prepared on how to designate their PRRC. However, due to the less notification of Notified Body (27 Notified Bodies for MDR and only 6 Notified Bodies for IVDR), the European Commission has published a project to facilitate the application of the IVDR:

- The EU IVDR Date of Application has not changed, but the rollout for the transition will. More than 80% of all IVDs in the EU are subject to notified body scrutiny, yet more than 50% do not have one.
- QMS should be ready by May 26, 2022 PMS, Vigilance, Registration, etc.
- Class A Non-Sterile IVD (no NB interaction-self declared) May 26, 2022
- All New IVDs with no current CE certificate May 26, 2022
- IVDs with valid IVDD CE certificates May 26, 2025, but given one year extra to sell off existing products. Ensure no significant change occurs.
- Those IVDs now Class D under IVDR (self-declared previously) May 26, 2025, but given one year extra to sell off existing products.
- Those IVDs now Class C under IVDR (self-declared previously) May 26, 2026, but given one year extra to sell off existing products.
- Those IVDs now Class A Sterile & B under IVDR (self-declared previously) May 26, 2027, but given one year extra to sell off existing products.
- Manufacturers of in-house devices, also known as laboratory-developed tests, have until May 26, 2024, to comply unless they can prove no equivalent product is available.
 If proof is provided, the European Union will give manufacturers until May 26, 2028, to comply.

This definitively demonstrates the high expectations devoted to that new position by both regulations the MDR and the IVDR. It confirms the need of highly responsible professionals to hold such a major regulatory role in the medical device and in-vitro diagnostic industry.
