

Drug courts are the single most successful criminal justice intervention for seriously addicted offenders. Proven to save lives, save money, and reduce crime.



Lipscomb University's Recovery Court Class



In March, District Attorney General Ray Crouch Jr. of the 23rd Judicial District spoke with Lipscomb University students in the Law, Justice, and Society Program about the district's successful recovery court program. Lipscomb University's Recovery Court class is the first college course in Tennessee, second in the nation, devoted entirely to training students about the recovery court model. The course is taught by Adjunct Professor Kevin Batts, who also serves as a Director of the 23rd District Recovery Court.

National Recognition

The First Judicial District Felony Recovery Court was named as one of 10 national mentor treatment courts by the National Association of Drug Court Professionals and the United States Department of Justice. This recovery court provides evidence-based holistic treatment including intensive outpatient services, gender-specific trauma groups for males/females, outpatient groups/individuals, parenting education, and family therapy. The NADCP mentor courts hosts teams from other jurisdictions for observation and peer-to-peer learning opportunities to test new treatment and recovery practices.



In other news, Families Free had their joint One Step program with A.C.T.I.O.N. Coalition featured at the National Rural Health Association's 33rd Annual Rural Health Policy Institute. Through the Building Communities of Recovery grant, their partnership with ACTION Coalition has increased the awareness and knowledge of recovery and built an infrastructure that provides recovery support services in Johnson County. ACTION Coalition has trained 13 recovery coaches in Carter and Johnson counties to date, developed and launched the One Step program model with Families Free, and helped individuals identify and access resources to help achieve their recovery goals.

STRONG Families Northeast Tennessee Pilot Program

State and local officials announced a three-year, \$25 million state grant for a community collaborative pilot project aimed at helping more than 1,000 families in a 10-county region of Northeast Tennessee. With the grant comes the launch of STRONG Families Northeast Tennessee, a pilot program that will use an innovative approach to increase economic mobility, self-sufficiency, and well-being for low-income families in Northeast Tennessee. Executive Director Lisa Tipton served on the Bright Start Steering Committee and Families Free is included as part of this grant.







Montgomery County Veterans Treatment Court

On February 24, 2022 Governor Bill Lee shared words of encouragement with the graduating class, recognizing their service to our country and the long, hard path that they chose to take towards recovery. The Governor also acknowledged that the Montgomery County Veterans Treatment Court Program was a model program in the State of Tennessee and that he was incredibly proud to be there. 
Tennessee Department of Mental Health and Substance Abuse Services
