

## Blount County Recovery Court Life Skills Program

Blount County Recovery Court and the Blount County Public Library have developed a Life Skills Program to serve Recovery Court participants. The project came to fruition after K.C. Williams, Blount County Library Director, presented to court participants. Afterwards, she reached out to Stephanie Monday, Recovery Court Treatment Specialist, to ask how library services can support the efforts of the Recovery Courts moving forward. Over a cup of coffee, they discussed the need for a Life Skills Program and from there a curriculum was developed and a new resource born for the community.

The program began with two groups. The Life Skills Program offered each group a one-hour presentation on life skills and a second hour was dedicated to a group session. The curriculum grew to eight modules being developed. The modules are stand alone, meaning a participant can come and go and not be impacted by having to miss a meeting. The modules meet criteria for adult learning and strive to reflect diverse life experiences, promoting ownership while building knowledge.

The eight modules on life skills include communication, financial, social, physical health, nutrition, personal appearance, the job interview, and the resume. The weekly group schedule is Monday 6:00 p.m. to 8:00 p.m., Tuesday 8:30 a.m. to 10:30 a.m., Wednesday 9:30 a.m. to 1:30 p.m., Thursday 6:00 p.m. to 8:00 p.m. The Blount County Public Library is located at 508 N. Cusick Street, Maryville, TN. For more information, go to Life Skills

## **Project Rural Recovery**

TDMHSAS, Buffalo Valley, Inc., and McNabb Center have partnered for Project Rural Recovery to address the behavioral health and physical health care needs of those who reside in underserved rural communities in Tennessee.

This five-year \$10 million grant is funded to reach 10 rural counties between these two providers, who both built and will operate two mobile health clinics. Services will be by appointment with the goal being to serve 2,000 Tennesseans, scheduling roughly 4,800 clinic visits a year.

Rural counties often have higher poverty rates and limited access to health care. Transportation can be an issue for many who must drive one to two hours to reach their closest hospital. The mobile clinic providers know the importance of preventative measures, offering screening services and referrals to patients who might not have known they needed a particular service before their appointment.

McNabb Center will serve Grainger, Cocke, Jefferson, Claiborne, and Hancock counties. Buffalo Valley, Inc. will serve Perry, Lewis, Wayne, Lawrence, and Marshall counties. Debbie Hillin, Senior Vice President of Buffalo Valley, Inc., states, "Our hope and our reason that we want to partner with the state was that we want something to be sustainable within the five rural counties that are at risk and distressed."




#### Milan Recovery Court

This has been two years of hard work and commitment and we are excited to celebrate the recent graduation of Scott and Tracie as they begin another chapter on their journey!






## 12<sup>th</sup> Judicial District Recovery Court

#### Thank You, Judge Grimes

The Tennessee Recovery Court Community lost one of our longest running judges. Judge Raymond Grimes, a general sessions and juvenile judge in Montgomery County, passed away at 73 on November 26, 2020 after being hospitalized for COVID-19.

Judge Grimes was elected to the bench in 1998. He earned his law degree from the University of Memphis in 1980 and practiced law in Clarksville before being elected judge. Judge Grimes presided over the Montgomery County Drug Court from the time he initiated the court in 2005 until his death. He served as president of the Tennessee Council of Juvenile and Family Court Judges in 2010. Sharon Massey Grimes, a Montgomery County attorney, was appointed to the Montgomery County General Sessions and Juvenile Court bench to complete the unexpired term of her husband, which will be up for election in 2022.

For Judge Massey Grimes the appointment represents the best move forward in a difficult situation. One part of her husband's legacy she is most passionate about continuing is the Montgomery County Recovery Court. Judge Massey Grimes recalled helping her husband draw up the policies and procedures of the court during its planning stages and noted the special satisfaction he got over the years from seeing how it helped turn lives around. "Ray took great pride in helping persons with addiction issues," Judge Massey Grimes said. "He was part of the team and never wore his robe in Recovery Court. He believed in the saying, 'You held out your hand and changed my life."




## 16<sup>th</sup> Annual TARCP Conference March 30 through April 1, 2021
